## Your Rights at Work: red

### flags to watch out for

- No written contract.
- It's not clear if you're casual, part-time, or full-time
- No payslips or weird pay setups (like cash-in-hand or unpaid "trial shifts").
- Unsure about awards or pay rates.
- No super or tax being paid.
- Being asked to work off the clock (yep, unpaid extra hours = not okay).



If something feels off, don't ignore it. Book an appointment.

## <u>Imagine chasing your</u> <u>own pay check</u>

### What you want to say...

"This isn't a discount job. I expect to be paid what I'm owed. Don't make me remind you again."

### What you could say instead...

Subject: **Question About My Recent Payslip** 

Hi [Manager's Name],

I just had a question about my most recent payslip — I was going over it and don't completely understand it. I thought I'd check in with you just in case.

Would you mind if we had a quick look together when you have a moment? I've kept track of my hours and will bring them along. Thanks for your time!

When is your visa expiring? Don't know: check online on the Department's VEVO for Visa Holders. Can't find it? Get in touch with us. We can help.

I didn't think moving into a sharehouse would end with me losing money, but that's exactly what happened. At first, everything seemed fine—three of us, all ANU students, splitting rent and bills equally.

Then Liam, one of my housemates, stopped paying his rent. He said it was a "bank issue," then just ghosted us.

Jess and I covered the bills, thinking he'd pay us back. He never did.

Eventually, I went to the ANUSA Legal Service to find out what my options were. That's when **I learned that under a co-tenancy, we were all equally responsible for rent and bills—so even though Liam wasn't paying, we were still legally on the hook.** 

I wish I'd known that before signing the lease. It felt like I was doing the right thing and still got burned.

## <u>Crimes and Fines</u>

All our advice is **confidential, judgement-free,** and **cost free.**

There are laws about that? Yes there are. If it's not a clear **yes**, it's a **no**.

### Consent has to be:

- Freely given not pressured, manipulated, or forced
- **Sober** not given when someone is too drunk, high, or unconscious
- Ongoing you can change your mind at any time
- Specific saying yes to one thing doesn't mean yes to everything
- **Informed** agreeing to sex with a condom does not equal to agreeing to sex without one

Under ACT law, consent means **free** and **voluntary** agreement to sexual activity. It must be **active**, **ongoing**, and **informed**.
