The positions of Women's Officer, Queer\* Officer, Indigenous Officer, BIPOC Officer, Disabilities Officer and International Students' Officer will all be elected internally by their respective departments and are not open to nominations in the annual elections (see ANUSA Election Regulations, R 7A).

### Am I eligible to nominate?

Any student may nominate for positions 1 through 9 above (Executive, General Representative, National Union of Students Delegate positions).

#### Council Members

Only undergraduate students, as defined in the ANU Governance Rule and Statute may nominate for the position of Undergraduate Member on ANU Council.

Only postgraduate students, as defined in the ANU Governance Rule and Statute may nominate for the position of Postgraduate Member on ANU Council.

#### Academic Officer

For the position of Undergraduate Coursework Officer, nominees must be students enrolled in an undergraduate program as defined by the University.

For the position of Postgraduate Coursework Officer, nominees must be students enrolled in an postgraduate coursework program as defined by the University.

For the position of Higher Degree by Research (HDR) Officer, nominees must be students enrolled in an undergraduate program as defined by the University.

### College Representatives

For positions 15 through 20 (College Representative positions), only students enrolled in the relevant College are eligible to nominate. For each college, two positions are designated as undergraduate positions, one position is designated as a postgraduate coursework position and one position is designated as a Higher Degree by Research (HDR) position. Students must be enrolled in a program in the relevant academic career to be eligible to nominate.

#### Parents and Carers' Officer

Nominees for Parents and Carers' Officer must self-identify as a parent and/or a carer.

# **Environment Officer**

Any student may nominate.

### Nomination by students intending to study a program in 2026

An existing ANU student who has been admitted to, applied for a program, or provides a statutory declaration of their intent to apply by no later than November 30 immediately following the election for the program is entitled to stand for election for positions for which a student enrolled in that program are eligible to stand (ANUSA Election Regulations, R 2.1.8D). This does not apply to the elections for Members of ANU Council.

### Legal obligations of nominees

Nominees should also consider whether they are disqualified from running for office by S 63 of the *Associations Act 1991* (ACT). The following people may be disqualified from holding office on ANUSA by legislation (unless they have obtained leave from the Supreme Court of the ACT):

- Those convicted of an indictable offence in relation to the promotion, formation or management of a company within the past 5 years.
- Those convicted of an offence involving fraud or dishonesty punishable by imprisonment for a period of 3 months or more within the past 5 years.
- Those who are bankrupt or personally insolvent.

Please note that the maximum penalty for non-compliance with these provisions is 50 penalty units, imprisonment for 6 months or both. #### How do I nominate?

Nominations must be submitted by emailing <a href="mailto:sa.admin@anu.edu.au">sa.admin@anu.edu.au</a>. Nomination forms will be available on the ANUSA website and must be signed by two other students endorsing your candidacy. Nomination forms will not be available until the Call for Nominations on August 20<sup>th</sup> 2025.

All candidates will be invited to submit an online nomination allowing them to complete an online biography and upload a photo to be made available to voters closer to the election. Individual nominations are due by September 12<sup>th</sup> 2025.

If you would like to run as a team, you must submit a ticket registration form to register your ticket name. All candidates running under that ticket are still required to submit individual candidate nomination forms noting their affiliation with the ticket. Ticket nominations must be submitted by September 10<sup>th</sup> 2025.

Any disputes about eligibility of tickets or candidacy shall be decided by the Returning Officer, whose decision is final.

#### Important dates

The call for nominations will occur on Wednesday 20<sup>th</sup> August, 2025.

Ticket registration opens 9am, Wednesday 20<sup>th</sup> August 2025, and closes 5pm, Wednesday 10<sup>th</sup> September 2025.

Candidate nomination opens 9am, Wednesday 20<sup>th</sup> August 2025, and closes 5pm, Friday 12<sup>th</sup> September 2025.

# When is the election?

The 2025 ANUSA General Election will be held during Week 8, Semester 2. Voting will take place online between 9am Monday 22<sup>nd</sup> September and will close at 12pm on Thursday 25<sup>th</sup>

# **Conduct expected of candidates**

It is expected that all candidates read the ANUSA Election Regulations before commencing their campaign. Candidates can access the Election Regulations on the ANUSA website (<a href="https://anusa.com.au/about/governance/">https://anusa.com.au/about/governance/</a>). Please refer to Appendix A detailing Electoral Offences. It is important to be aware that commission of an Electoral Offence can result in penalties including financial penalties, disqualification of a candidate or loss of membership. ## How do I make a complaint?

All complaints against candidates and breaches of the Electoral Regulations can be made to the Probity Officers (<a href="mailto:sa.probityofficers@anu.edu.au">sa.probityofficers@anu.edu.au</a>). It is recommended you specify details of what happened and what regulation you think has been breached.

#### **Exclusion zones**

It is an offence to actively canvas votes in the designated Exclusion Zones. Please refer to the end of this document for a map and list of Exclusion Zones for the elections.

# Appendix A

#### **Electoral Offences**

It is an offence to place on any notice board an election notice larger than A3 size.

It is an offence to publish any material that contains untrue statements or misrepresentations likely to mislead a voter in the casting of their vote.

It is an offence to remove from any place any Electoral Publication. No offence is committed by:

- a person removing a reasonable quantity of the publication for their own or another's information:
- a member of the group in whose name or on whose behalf the publication is posted;
- a person authorised by a member of the group in whose name or on whose behalf the publication is posted; or
- a person who has the right to control the entrance to the place where the publication lies or that person's agent.

It is an offence to actively canvass votes within the areas specified in Schedule B to these Regulations.

It is an offence to attempt to ascertain the way a person votes. For the purposes of this section, it is an offence to attempt to watch how a person casts their vote while they are voting.

It is an offence to cast or attempt to cast a vote to which the person is not entitled.

It is an offence to offer gifts, bribes, money, food, drink, or any other enticement, or to otherwise exert undue influence, over electoral officials or voters at any time. For the purposes of this section, animals are not an enticement to vote.

It is an offence for an individual who is not currently a student at the university to campaign for a candidate in the election. For the purposes of this section, it is an offence for candidates and members of their campaign team not to carry their student cards while campaigning.

It is an offence to engage in negative discrimination, harassment or intimidation. This includes any repeat unwanted contact to incite somebody to vote, or any other coercive conduct, either online or in person.

It is an offence to actively canvass votes from a person displaying the opt-out item in accordance with section 2.5.4, provided the opt-out item is easily observable by candidates and members of their campaign team.

It is an offence to incite any other person to commit any of the Electoral Offences detailed in this section.

If, in the opinion of the Returning Officer, a candidate or a member of their campaign team behaves in a way that violates the spirit of the Constitution or these Regulations, the Returning Officer may deem that behaviour to constitute an Electoral Offence.

It is an offence to campaign outside of the Campaign Period.

For the purposes of 3.1.12, the Campaign Period means the period starting when the Returning Officer issues the notice of the call for nominations under Regulation 2.2.1A and ending at the close of voting.

For the purposes of this Regulation 3.1, to campaign includes any of the following acts or the inducement of those following acts by another person by a member of ANUSA who intends to run for office: publicly announcing an intention of any person to stand for office, publicly announcing the purported name of any ticket or grouping for an ANUSA election, canvassing for votes for an office to be filled at an ANUSA election, and publishing or distributing Electoral Publication.

### **SCHEDULE B - EXCLUSION ZONES**

Section 3.1.3 provides that it is an offence to actively canvass votes within the areas specified in Schedule B to these Regulations.

For the avoidance of doubt, the following areas are 'exclusion zones':

- 1. Kambri Precinct (bound by North Road (non-inclusive), Tangney Road (non-inclusive), Joplin Lane, and Kingsley Street)
- 2. The Copland precinct, including the ramp and stairway to Kingsley Street;
- 3. Inside residential halls, and a 15-metre radius around associated entrances;
- 4. The small footpath next to University Avenue between the Copland Courtyard and Kambri;
- 5. The Tjabal Centre;
- 6. Inside ANU libraries, and associated walkways;
- 7. Inside ANU rooms where lectures, tutorials, labs, or other teaching takes place, including online spaces;
- 8. Inside any autonomous department space; and
- 9. Inside David Cocking Sport and Recreation Centre

In addition, no campaigning other than putting up posters may take place inside any other building on the ANU campus.

Campaigners are permitted to campaign in all other areas.

For the avoidance of doubt, the Returning Officer or their nominee will clarify exclusion zones before the beginning of

the Campaign Period. This includes but is not limited to a map of exclusion zones.

The Returning Officer or their nominee may temporarily suspend an area so debates or other informative events may be held.

Any changes to electoral offences or other regulations governing elections will be communicated to all candidates and students if and when those changes are considered and passed at a General Meeting of the Association.
