## **Special Resolutions**

If you wish to present constitutional changes by Special Resolution, you should contact the General Secretary ([sa.gensec@anu.edu.au](mailto:sa.gensec@anu.edu.au)) **as soon as possible**. Changes must be notified to the University Governance Office five (5) weeks before the General meeting, per the protocol for student organisation constitutional amendments which applies to all organisations in receipt of SSAF. Additionally, at least twenty-one (21) calendar days' notice of the proposed Special Resolution must be given to all students.

## **Who can come?**

ANUSA General meetings are open to all students at the ANU. All Representatives of the Association are required to attend.

All ANU students can propose, move, second and speak to motions. Additionally, all students may vote on motions at a General meeting.

## **How do I submit a motion?**

Motions must be submitted to the General Secretary on [sa.gensec@anu.edu.au](mailto:sa.gensec@anu.edu.au) by the due date above. Any ANU Student may move and second motions.

If you want to submit a motion, here are some helpful tips:

- Submit with enough time before the deadline. This allows time for changes to be made before the meeting if required.
- Think backwards: start with your goal in mind and then write a motion that advances towards your intended goal.
- Consult people with relevant experience, which may include (but is not limited to) the ANUSA Executive, Department Officers, ANUSA-affiliated Clubs, Residential Hall leaders, or former ANUSA representatives who have done similar work.
- Make sure your motion is within the powers of the meeting, doesn't contradict the ANUSA Constitution or Regulations, complies with ACT and Federal laws, is not defamatory towards any individuals, and is clear and concise.
- Reach out to the General Secretary via email if you need advice.
