### Motion 4.1

ANUSA approves the 2021 Provisional Budget [Reference C]

Mover: Siang Jin Law

Mover:

- A budget Maddy drew up – probably won't get this in the SSAF bid
- This is our ideal budget – Maddy ran 3 consultations and got feedback and it will probably look different next year but this is ideally what we would get

Q: Can you clarify the difference between training and leadership and professional development?

A: Training etc is slightly different in terms of aims – first aid for SRC members. Different outcomes and for different people as well.

Q: We don't have the final figures for SSAF pool and noting ANU has pre-allocated funds – is there any indication as to what proportion of the pool will be going to ANSA?

A: Currently every year we get about 30% of the pool and it is what looks like right now but it is not currently confirmed.

Q: Jin ran on a platform for putting up a storefront – how much will be planning to invest in that and will it be included in budget?

A: Consensus is that it is hard to work that out right now. How much we put towards the budget will be up to the next year's SRC. If it is then plan then I will write it onto the official budget.

A: For the TAG stuff, whatever is happening this year will come out of this year's budget. Whatever happens in the future will come out of the consultancy line item. Wasn't too much money before and hopefully it won't be too much this time either.

Q: Do you think it is good that staff salaries line item is 61% of the total?

A: Tricky to answer. We have to increase staff salaries every year by 2%. 61% is a big chunk but it will hypocritical to not pay SSAF properly. It is a sensitive topic but depending on what happens next year, we will have to look at that.

## **Motion 4.2**

### **Election Regulations - membership of ANUSA**

#### **Preamble:**

The Election Regulations currently contain a contradiction about who is eligible to nominate and vote for elections. Section 2.5.3 states that '[t]he Returning Officer or their nominee must prepare a list of ordinary members eligible to vote at the Annual Elections.' However, sections 1.1.5, 1.1.7 and 1.1.8 state that voting and nominating for elections can only be done by 'Undergraduate Students'. Undergraduate Students are only one section of ANUSA's membership, as membership is defined in the Constitution as extending to Undergraduate Students and students enrolled in an ANU Pathway Program. To make the language of the Election Regulations consistent, 'membership of the Association' should be the language used throughout the Election Regulations.

#### **Motion:**

Amend 1.1.5 to:

"1.1.5 Unless the Constitution provides otherwise, any member of the Association elected under the Constitution or these Regulations holds office for 12 months commencing on 1 December in the year of their election."

Amend 1.1.7 to:

"1.1.7 Only members of the Association are eligible to vote for, or stand for election to, a representative position within the Association."

Amend 1.1.8 to:

"1.1.8 Only members of the Association are eligible to vote in a Referendum of the Association."

Amend 7.1.1(a) to:

“(a) Environment Officer - any member of the Association may vote or nominate.”

Mover:

- This motion goes to the issue about membership in ANUSA, which is made up of undergrads but also ANU pathway program students.

#### **Election Regulations - release of vote count**

Add Reg 1.3.8 to the Election Regulations:

“1.3.8 As soon as practicable after the counting of votes in an election has been finalised, the Returning Officer or their nominee must publish the full results of the vote count, including preference allocations.”

Add Reg 2.1.9A to the Election Regulations:

“2.1.9A The Returning Officer’s report must contain the full results of the vote count.”

To add section 3.1.6A to the Election Regulations:

“3.1.6A It is an offence to attempt to bribe people by offering them employment in the Association or positions within the Association that would otherwise be decided in line with the Constitution, Regulations and policies of the Association. For the purposes of this section, it is also an offence to:

- (a) accept a bribe of this nature;
- (b) offer to use your influence to increase the likelihood of employment; and
- (c) deceive other candidates by pretending to make this offer.”

No more than half of the budgeted amount for honoraria may be allocated within the first Semester. Unallocated funds from the first Semester may be allocated in the second Semester.”

S 3.3.5: “3.3.5 Nominations received will be reviewed by a committee (the Committee) comprising the ANUSA President (or nominee), ANUSA Treasurer, a Department Officer, a College Representative, a General Representative and a member of the Clubs Council Executive.”

## **Motion 4.7**

### **Ethnocultural Department renaming**

#### **Preamble:**

Recent events and conversations within the Ethnocultural Collective have brought to light the vague and conflationary nature of the name and definition of who this department represents. We propose a change to more clearly and to explicitly acknowledge the diversity of our collective (not just People of Colour, but also Black and Indigenous identifying students). 2020 has shown us how different members of the current Ethnocultural Collective have very different interactions with racism and the status quo, and we want to reflect this.

We found through our interactions in Semester 1 that members of our collective both knew and identified with the term POC and BIPOC more than 'Ethnocultural'. We hope the name change will help welcome more students to this space.

#### **Motion:**

To amend the following sections of the ANUSA Constitution:

S 9(3)(g): "Bla(c)k, Indigenous and People of Colour Department"



S 11(3): “The Women's Officer, Queer\* Officer, Environment Officer, Indigenous Officer, International Students' Officer, Disabilities Officer, and Bla(c)k, Indigenous and People of Colour Officer are responsible for the management of the affairs of their respective Department.”

S 14(1)(c): “the Department Officers from the Disabilities, Environment, Indigenous, International Students', Queer\*, Women's and Bla(c)k, Indigenous and People of Colour Departments; and”

S 14(3)(g)(vii): “the Bla(c)k, Indigenous and People of Colour Department;”

## **Motion 4.8**

### **Committee of the Association**

#### **Preamble:**

- This amendment is to clarify an unclear section of the Constitution.
- Although the SRC is currently stated to be the ‘committee’ (s 14(1)), the Executive is stated to ‘manage[s] the affairs of the Association’ (s 10(1)(a)). This is inconsistent with the role of the committee under the Associations Incorporation Act to manage the Association.
- In practice, the Executive manages the Association as the executive organ of the Association, and thus should be clarified to be the committee.
- This will not change the role of the SRC in any way, and will maintain their oversight function of the Executive.

#### **Motion:**

To amend the following sections of the ANUSA Constitution:

S 10(1)(c): "The Executive is the committee of the Association in accordance with the Act and must:"

S 14(1): Remove "shall be the committee of the Association in accordance with the Act and"

Mover:

- This is a bit more technical.
- First thing – this does not remove any oversight for SRC in doing their role.
- Reduce the legal responsibility of gen reps and college reps in day to day things.
- This will not change the role of the SRC in any way.

- This is a bad idea – this will have a lasting impact.
- What this does – gives more power to the ANUSA executive.
- The SRC will be limited if this passes.
- I cannot find other student association is like this – the model constitution even has non-executive members on the committee.
- This will damage representation of for clubs that do not agree with executive.

F:

- One reason I think it is important – currently every member of the SRC has directors duties.
- My belief is that requires a level of knowledge that not everyone who is a gen rep or college rep has.
- It requires them to be ultimately responsible if the association makes a bad decision.
- Representatives should be able to vote for the bodies they represent.

Point of clarification: Directors duties – duties being discussed are context dependent so they are different.

A:

- Agree with Jacob on this.
- This isn't just about reducing the legal risk.
- It pushes the members of the executive to be more transparent and pushes ANUSA as a whole to be more transparent and accountable.

F:

- Tend to agree – trying to divert legal responsibility.
- As a former department officer – I can see a conflict for the best interest of the department vs best interest of the committee.
- It can help mitigate that risk.

- First thing – SRC already performs these duties.
- It is important to note that SRC can still maintain a level of financial scrutiny.

## Motion 4.9

### Duties of Officers

#### Preamble:

- The Associations Incorporations Act has been amended to clearly set out duties of "officers" as defined by the Act. These duties include the duty to act with care and due diligence; the duty to act in good faith; the duty not to improperly use office for advantage; and the duty not to use information gained from office for advantage. Currently these concepts do not appear in the Constitution, although similar duties appear in the ANUSA Code of Conduct.
- Further the Act clarifies duties of officers in respect of conflicts of interest, which are more stringent than what currently appears in the Finance Regulations. The Act only applies these duties to the members of the Committee of Management. The draft below would extend the same standards to all Officers as defined in the ANUSA Constitution.
- Including these provisions explicitly in the Constitution ensures officers are aware of these legal responsibilities which apply by virtue of the Act, whether or not they are explicitly mentioned in the Constitution.
- Officers are defined in the Act as including anyone who serves on the "Committee of Management" and anyone who "takes part in the management of the Association's affairs". The precise scope of this provision is a little uncertain.
- As used in the proposed amendment "Officer" would have the meaning provided in section 2 of the ANUSA Constitution and would ensure a common standard of conduct for all elected officers of the Association)
- No consequential amendments arise from these changes.

#### Motion:

Add "22A. Duties of Officers" to the ANUSA Constitution Table of Contents.

Add section 22A to the ANUSA Constitution, which reads as follows:

#### **"22A. DUTIES OF OFFICERS**

- (1) An Officer must act with care and due diligence in the exercise of their functions and duties. (Reference: Section 66A of the Act)
- (2) An Officer must act in good faith in the best interests of the Association and for a proper purpose in discharge of their duties. (Reference: Section 66B of the Act)
- (3) An Officer must not improperly use the Officer's position to gain advantage for the Officer or another person or to cause detriment to the Association. (Reference: Section 66C of the Act)

- (4) An Officer must not use information gained in that role to gain advantage for that person or another person or to cause detriment to the Association. (Reference: Section 66D of the Act)
- (5) An Officer must disclose the nature and extent of any material personal interest of the Officer in any matter arising before a meeting in which the Officer has a vote, and the disclosure must be recorded in the minutes of the meeting. (Reference: Section 65 of the Act)
- (6) Disclosures of material personal interests must be reported at the next General Meeting of the Association. (Reference: Section 65(1) of the Act)
- (7) An Officer who has a material personal interest in a matter before a meeting in which the Officer has a vote must not be present while the matter is considered or vote on the matter. (Reference: Section 65A of the Act)
- (8) For the avoidance of doubt, in this section, Officer has the meaning defined in this Constitution.”

## **Motion 4.10**

### **General Representatives**

#### **Preamble:**

- There was general support in the consultations for reducing the number of General Representatives.
- Note that these changes alter the number of Gen Reps, but does not change their functioning or their status on the SRC.

#### **Motion:**

To amend s 14(1)(b) as follows: “(b) ten (10) General Representatives”

Mover: Jacob Howland

Secunder: James Eveille

Mover:

- Moving this mostly so that everyone has a chance to vote on it.

- It is merit both ways – keeping the same number vs reducing it.
- Reducing merit – a small group of people will keep up to date with the requisite information and keep engaged.
- I think that given reports from consultations, it should be put to a vote.

Secunder:

- Reducing the number – this is an important move forward.
- ANUSA has a higher number of gen reps compared to others in the country.
- Probably good idea we have a lower number of gen reps who have directors' duties.
- A lot of gen reps don't do their job – smaller group will make them better dedicated.
- This does not take away that gen reps will be a big group on the SRC.
- It is crucial that we acknowledge that SRC has 39 members which is a massive number.
- We have gen reps who are more dedicated to the role and can perform better.

A:

- A lot of good arguments in both directions but this harms the association.
- A smaller number of gen reps will not make them more dedicated.
- Reps aren't voted based on how engaged they will be but rather on clout.
- Shrinking down the number of gen reps won't get you anywhere – it is free labour and so make use of it.

F:

- One of the crutches is that the hierarchical structure.
- Led to a large number of people who wanted to contribute outside of that.
- There are costs that are related but they are more like retreats etc.
- Lessening it will strengthen that empowerment rather than the opposite.

A:

- Before I was a rep – the vast majority weren't reps and that is where people interact with ANUSA the most.
- I think is an issue that is not related to lessening the gen reps number.
- People who are in the last votes after 10 have contributed more than me.
- This year diversity was an issue – not just women and international student and how will reducing the number impact that.
- We never vote as a group – so lessening will take away the voting opportunity.
- More gen reps leads to more diversity.

F:

- ANUSA is unique – we allow any member to come to SRC and put motions up.
- We have students who are engaged and put up motions.
- Over the years lots of people who weren't elected, still were engaged.
- We are having trouble hitting quorum every time – the larger the number of people on the board – the less individual responsibility each person has.
- Harder for exec to check in with people.

- Being a gen rep – you have responsibility and assess the merits of proposals that are brought to them.
- Hold gen reps accountable by people who elected them.

A:

- The role of the gen rep team has been brought up a lot.
- From the conversations – quite a few problems with this motion.
- Reducing number of gen reps will not make the problems go away.
- Gen rep accountability – the solution is to increase support and resources.
- The reality is that there are gen reps that are elected and don't keep promises.
- This doesn't equate that gen reps with least number of votes to how much dedicated they are.

- Comes down to two things – raised issues of democracy and diversity.
- Also don't want to dehumanized the value and work done by gen reps.
- There is a mismatch in the expectations we place on the support we are supposed to provide to the reps.
- We do not have enough people to individually who can support gen reps personally.

Procedura motion!: Two more speakers for and against.

A:

- Don't think the way we solve the support problem is by decreasing representation of gen reps.
- We are here as a student union and our job is to represent interests of our members.
- It would be a detriment to ANUSA if we decrease the number of reps who represent the best interests of the students.
- There is a broader problem of lack of engagement – the way to solve this is by having a culture of work and engagement and this strengthens representation.
- The ability to represent diverse students will be hampered if we reduce the number of gen reps.

- Just speaking to allow the against speaker to speak.

A:

- Quite telling – it is gen reps who are speaking against this.
- John is right – there are alternative approaches to fixing the issues raised than simply reduce the number of gen reps.
- Being a gen rep is so much more than attending SRC meetings – includes membership on a number of committees.
- Don't think we can draw equivalence between ordinary members of the association and the gen reps.
- We've seen a number of reps who have done great work. We also have some who didn't do great but I don't see how the issue is so large that we must reduce the number of gen reps .

## **Motion 4.11**

### **O-Week and Bush Week Directors**

#### **Preamble:**

- Governing employment is irrelevant to include in the Constitution. Hiring decisions can be made without being required by the Constitution.
- This section also raised significant problems this year in the context of COVID-19 where we did not have a normal Bush Week that required the standard hiring of Bush Week Directors. This raises questions of how this section would operate if we did not have an O-Week or Bush Week in the future.

#### **Motion:**

Remove s 18 from the ANUSA Constitution:

#### **“18. ORIENTATION WEEK AND BUSH WEEK DIRECTORS**

(1) There are to be Orientation Week and Bush Week Directors, who will report to the Social Officer.

(2) The Directors must:

- (a) organise a variety of daytime and nighttime social events for members of the association;
- (b) organise a Market Day where affiliated Clubs are able to promote themselves; and
- (c) develop sponsorship relationships with organisations.

(3) Orientation Week and Bush Week Directors must be available to the Social Officer during the teaching break in the direct lead up to either Orientation Week or Bush Week.”

Mover:

- We have 2 positions that are employed as employees.
- This has no application in how we do anything.
- The two positions will stay.

## **Motion 4.12**

### **Natural justice**

#### **Preamble:**

- The change to s 7(2)(b) clarifies language and grammar.
- S 7(3A): The Disputes Committee ruled last year that the rules of natural justice apply to the determination of disputes between members of the Association. Incorporating this amendment will formalise this decision and tie our Constitution in with the Associations Incorporation Act.

#### **Motion:**

To amend the following sections of the ANUSA Constitution:

S 7(2)(b): “by a decision of the Disputes Committee.”

S 7(3A): “In determining any dispute between members or between a member and the Association, or in making disciplinary decisions under this Constitution, the Association must comply with the rules of natural justice and the requirements of the Act. (**Note:** See sections 50, 65B and 65C of the Act)”

## **Motion 4.13**

### **Record of meeting decisions**

#### **Preamble:**

- This section sits alongside the amendments to s 26 (below) to provide access to the minutes of all meetings of the Association.
- As the Executive carries out important functions on behalf of ANUSA it is important that its decisions be recorded and available to members.
- Minutes are the standard method of recording decisions and are already required to be kept under the Constitution. Section 251A of the Corporations Act requires the keeping of minutes, as does section 14 of the model rules under the Associations Incorporations Act. Under 251B of the Corporations Act and under section 36 of the model rules, members have a right of access to minutes (and indeed records) of an Association.
- Under the Associations Incorporations Act there is a qualified right of access to minutes and other key records (s. 35 of the Act), however access can be restricted as allowed by the Act and as provided by the rules of the association (s. 35A).
- The inclusion of a formal signing process ('signed by the presiding officer') is a usual requirement for minute-taking which gives formality to the process. This would prevent drafts ending up as the formal record of a meeting.

#### **Motion:**

To amend section 10(11)(b) of the ANUSA Constitution as follows:

"(11) The General Secretary must, subject to the Constitution, the Regulations and Policy of the Association: ... (b) ensure that minutes of meetings of the Executive, the Student Representative Council, General Meetings and other meetings of the Association, including a basic summary of discussion, are recorded, signed by the presiding officer and retained;"

To add section 10(5A) to the ANUSA Constitution:

“If the Executive makes a decision outside its regular meetings, the decision must be recorded in the minutes of the next regular meeting of the Executive.”

## **Motion 4.14**

### **Access to minutes of meetings of the Association**

#### **Preamble:**

- ANUSA has a range of bodies and organs which meet and record minutes of their meetings (subject to the Standing Orders).
- The Freedom of Information provision provides for access to records, but only in respect of meetings of the Clubs Council Executive is access to minutes (in the form of publication) addressed.
- A consistent standard is required across ANUSA for access to minutes.
- This amendment would provide access to the minutes of Executive meetings.
- A general principle established by the Associations Incorporation Act is that members have a qualified right of access to a "summary of minutes" of the committee of the Association, as well as certain other documents (s. 35(1) of the Act). Access can be restricted where disclosure would be "prejudicial to the interests of the Association". An example is where breach of confidentiality might arise, or where disclosure may expose an Association to other legal risks. These principles are extended to other documents which members may be able to access under the rules of an Association. (s. 35A of the Act) and empower an Association to impose restrictions or conditions on access.
- Section 26 of the ANUSA Constitution already provides for Freedom of Information. This amendment would specifically deal with access to minutes, without altering the general principles of that section.
- The proposed language is general and would allow publication to occur via a website or otherwise as might be ANUSA practice from time to time. It would not require disclosure to non-members, as normally non-members don't have a right of access to minutes of an association.

“(2) Except for minutes containing confidential or personal information, and minutes of Departments, the General Secretary must cause or require minutes of meetings of the Association to be made available to members of the Association.

(a) except for minutes containing confidential information, cause or require minutes of meetings of the Department to be made available to members of the Department.”

- Agree with both James and Ben – provide a distinction between option 2 and 5.
- The only group number 2 would exclude from number 5 are the graduated students.
- ANU college is a vast part of ANU but is an underrepresented part of ANUSA.
- ANU college isn’t technically a part of ANU – it is a subsidiary.
- ANU signs a privacy contract with ANUSA about student data.
- Vast number of elections could be declared invalid by our constitutional metrics – number 2 does satisfy that.
- University can give us data about ANU students.

- That's why I prefer number 2 to number 5.
- I don't understand how changing the definition of undergraduate student will impact anything.
- Current students – people currently enrolled. I personally don't know how long ANU college keeps data about student enrollment and we don't know if the university will even give us the data about students who have graduated.

Procedural: 10 minutes of speaking time.

- Concern with number 5 – it would cover a post-graduate students if they had studied a full undergrad role within the past 2 years and not sure if ANUSA should be opened to them.

- There are special circumstances where ANUSA should provide support can be captured within tailored “exemption”.
- Q – do we know how this will interact with micro-credentials of the university? We should represent as much as possible.
- People doing micro-credentials tend to be enrollees rather than student and they won't be paying SSAF and so none of these definitions would include that.
- Couple things about what Andrew said – I disagree with overall point. If this was only being proposed in response to issues that have risen this year then that is problematic. Option 1 and 4 mirror what currently exists. The reason why this came up is that the current wording is quite ambiguous and it is unclear whether you have to be enrolled in courses in the current or next semester or whether you just have to be enrolled in a program. There's two ways proposed here, and I would encourage you to vote for one of them so there is a clear definition. There are similar cases that can arise from other years. It is worth considering extending this.
- I agree with Jacob about why it's important to vote at least one of these. Any future gen sec can change the definition in the future. That seems like a big problem. Other options have a ability for people to have a semester of courses and still have ANUSA would be valuable. People should be able to vote in elections or come to meeting even if they have to drop because of mental health, etc.
- Not convinced that altering the definitions would remove the power from gen sec from having the power to interpret. Moving 5 different motions doesn't make sense – find one definition that everyone agrees on and then debate it. I would favour agreeing with university just for simplicity. It makes no sense to allow someone from another university who did a summer research should be allowed to run for office.

## **Motion 4.20**

### **Clarification of powers of interpretation**

#### **Preamble:**

- The purpose of this amendment is to clarify the relationship between interpretive powers of the General Secretary, the person presiding at a meeting, and the Disputes Committee. Currently other than that a person presiding interprets during a meeting, it is not explicit that a meeting is bound by a pre-existing interpretation of the General Secretary. Further the Disputes Committee also exercises implicit interpretive powers, and it is not explicit that a Disputes Committee ruling could displace an interpretation of the General Secretary. Currently the Constitution does not explicitly address the interpretation of policies, an issue which often arises in practice. Powers for interpretation of policies are made explicit. The changes will clarify the operation of interpretive powers under the Constitution.
- Subsection 1 states the general rule that the General Secretary interprets the Constitution, the Regulations and policies. A single source of interpretation provides certainty and stability to ANUSA which is an important reason to have a clear primary source of interpretation. This does not change the current principle in the Constitution.
- Subsection 2 provides when a General Secretary interpretation may be overruled and substituted with another interpretation. The purpose of a high threshold is to promote certainty and stability in constitutional interpretation. The subsection also clarifies that the Executive can substitute its own interpretation for an overruled interpretation of the General Secretary. This provision is essentially to provide a protection against misuse of the power of interpretation.
- Subsection 3 provides that subject to any existing interpretations of the General Secretary and the Disputes Committee, a person presiding interprets the Constitution, the Regulations and policies during a meeting.
- Subsection 4 allows for the Standing Orders to establish rules for dissent from an interpretation rendered by a person presiding at a meeting.



- Subsection 5 provides for the powers of the Disputes Committee to interpret the Constitution, the Regulations and policies in its exercise of powers under the Constitution.
- Subsection 6 provides that an interpretation of the Disputes Committee effectively replaces an interpretation of the General Secretary, either from the time of its decision, or as provided by the Disputes Committee.

**Motion:**

To amend section 3 of the ANUSA Constitution as follows:

“3. INTERPRETATION

(1) Subject to this section, the General Secretary interprets this Constitution, the Regulations and policies.

(2) An interpretation of the General Secretary may only be overruled and another interpretation substituted:

(a) by an at least 5/6 majority decision of the Executive carried at a meeting of the Executive; or

(b) as provided in subsection (6).

(3) Subject to any previously recorded interpretations of the General Secretary and the Disputes Committee, during a meeting the person presiding at the meeting may interpret this Constitution, Regulations and policies.

(4) A motion of dissent from an interpretation of this Constitution, the Regulations or policies by a person presiding at a meeting, moved during that meeting, may only be carried in accordance with the relevant Standing Orders.

(5) In determining any matter referred to it under this Constitution, the Disputes Committee interprets this Constitution, the Regulations and policies for the purposes of that determination.

(6) If, pursuant to subsection (5), the Disputes Committee varies an existing interpretation, or adopts a new interpretation of the Constitution, Regulations or policies, the Disputes Committee shall cause the changed or new interpretation to be published, including by providing a copy to the General Secretary.”

## Multiple office-bearer positions

### Preamble:

Currently, the Constitution allows for the simultaneous holding of multiple voting positions on SRC, with the only disallowed combination being that of someone being on ANUSA Exec and a Department Officer. Right now, though, someone could theoretically be on ANUSA Exec, and also hold the positions of genrep, college rep (and theoretically could represent multiple colleges) and Clubs Chair. This hypothetical person would also only hold a single vote. This presents a number of problems:

1. It collapses what should be a broad-base and representative SRC into a body that could feasibly be reduced from 39 people to one that is substantially smaller and less representative
2. It prevents all of these positions on SRC from being able to effectively fulfil their purpose of representing particular interests - how can someone exercise a single vote in the best interests of what could be several different positions, all seeking to serve particular groups?
3. It could turn elections into a mess where individuals are simultaneously contesting up to 4 positions - and it is easy to imagine this becoming a norm that locks people from outside of the association out of ever holding genrep or college rep positions if they are consistently contested and held by people with a more established presence in the Association.
4. There is also a potential problem with ANUSA Exec members also holding positions on Clubs Council, which is a serious issue in terms of preserving the independence of Clubs Council, as well as ensuring that the GenSec is able to act as an effective appellant body for Clubs Secretary decisions.

This motion prevents all of the above issues by preventing multiple voting positions from being held by any single individual.

To add section 9(8A) to the ANUSA Constitution: "(8A) No person may concurrently hold more than one position listed in Schedule 1."

To amend the following sections of the ANUSA Constitution:

S 9(9):

"(9) The position of a Representative of the Association becomes vacant if they:

- (b) cease to be a member of the Association;
- (c) resign their position in writing to the General Secretary;
- (ca) take up another office listed in Schedule 1;
- (d) in the case of a College Representative, cease to be enrolled in the College that they represent;
- (e) become an insolvent under administration as defined in the Corporations Act 2001 (Cth); or
- (f) are disqualified from office pursuant to any relevant section of the Act."

S 10(2):

"(2) No member of the Executive shall hold office as a Department Officer or, other than serving ex officio as provided in this Constitution, as a member of the Student Clubs Council during the tenure of their position as a member of the Executive."

See section 63 and following.

- This issue can be addressed by an amendment to the Election Regulations.

To add Regulation 1.1.10 to the Election Regulations: “A person disqualified by the Act from serving in a position elected under these Regulations is not eligible to stand for election. (**Note:** See section 63 and following of the Associations Incorporation Act 1991 (ACT))”

- (a) to promote the welfare of, and further the interests of, Undergraduate Students;

- (d) to foster student life by providing support and representation for Clubs; and
- (e) to foster community, equity and diversity within the University.”

- Currently the relationship is not made explicit and this can lead to potential issues (e.g. ANUSA being seen as directly responsible for actions of clubs or seen as controlling clubs).
- Further the clarification will make clear that affiliation (while not amounting to membership) involves the acceptance of certain rights and obligations as specified in the ANUSA Constitution and Regulations. Establishing clubs as members of ANUSA would involve significant changes for both ANUSA and clubs given the provisions of the Associations Incorporation Act and is not contemplated here.
- The new explicit language seeks to reflect current practice rather than modify it. It uses the word "affiliation" to describe the nature of the relationship (following that current practice).

#### **"Affiliation of Clubs**

- (1) Clubs, by affiliation with ANUSA, accept the rights and obligations applicable to them in this Constitution and the Regulations.
- (2) Clubs are not members of ANUSA.
- (3) Clubs are independent student groups affiliated with ANUSA for the purposes of this Constitution."

(4) Where voting is required at a meeting, whether in person or by technological means, the chair of the meeting shall ensure that the vote is transparent.”

- Officers are positions typically created by the Constitution which can sometimes be filled by election by the SRC (e.g .if a casual vacancy arises or the SRC is empowered to elect the officer).
- Committees appointed by the SRC are different and as they are temporary bodies established to carry out a sub-function that the SRC could carry out itself, the committee can also be restructured or its operation ended, in accordance with needs from time to time.
- The SRC does not have power to disestablish or re-define positions that are provided for in the Constitution, nor to establish a committee which exceeds its own powers.

##### **Preamble:**

- The Constitution currently contains a balance between the roles of the SRC and General Meetings, allowing the SRC to over-rule a General Meeting in certain circumstances, but limiting that power where a motion is "entrenched". Thus the SRC can overturn an amendment to the Constitution or Regulations by a 2/3rd majority vote of the SRC unless the motion is "entrenched".
- However section 13(4) of the Constitution provides that a motion is entrenched if it is "voted on by eighty (80) or more members of the Association in accordance with the provisions in Standing Orders concerning the entrenchment of motions."

- There is however no reference to entrenchment in the Standing Orders. It is unclear therefore what the intent of the reference to Standing Orders is. In any case the relationship between decisions of the SRC and decisions of a General Meeting should be clearly specified in the Constitution itself. Often a supermajority (for example 2/3rds in favour) is used as a marker for a kind of decision that might be protected from usual revision processes. (A similar super majority is required for overturning a decision of a General Meeting - see section 14(3)(e)).

**Motion:**

To amend section 13(4) of the ANUSA Constitution as follows:

“(4) If any motion put to a General Meeting is voted on by eighty (80) or more members of the Association and is carried by a 2/3rds majority vote, then:

 (i) any subsequent motion of the SRC or the CRC; or

S 13(15)(b): “the General Secretary’s Report on the financial position of the Association at the end of the previous Financial Year;”

S 22(2): “The budget of the Association must be presented by the General Secretary to the first General Meeting held in the first Teaching Period of the Academic Year.”

## 2. Reserves

We will be contributing \$2,000,000 to a short-term interest saver when our next SSAF instalment is paid from the University. This will leave ANUSA with approximately \$800,000 in operating until January 2021 which is adequate for the operation of the association.

## 3. Updated Budget

This year has seen ANUSA change our budgeted line items significantly to accommodate for the changes required by COVID. After the latest proposed changes to the budget line items presented at this OGM are voted on, I will publish an updated budget for SRC 7.

The Probity Officers would like to thank all of the above, the ANUSA Executive and staff, the candidates, and all members of the Association for their conduct during the election period.

## Election Overview

This report covers significant issues that occurred during the course of the 2020 ANUSA elections. The Probity team would like to once more thank the ANUSA Executive and staff and the Returning Officer for their support in this election period. Probity would also like to congratulate all of the tickets and candidates for how they managed their campaigns in the difficult circumstances faced during this year's election

Section 3.1 had been recently introduced into the Electoral Regulations allowing the Returning Officer to issue directions waiving requirements of the provisions of the Electoral Regulations if a force majeure prevents or inhibits the provisions of the Electoral Regulations.

Unfortunately, this year's election period was during the COVID-19 pandemic. Due to the COVID-19 pandemic, the Returning Officer declared this to be a force majeure and issued directions relating to the call for nominations and the ballot box for nominations. Those directions were as follows:

### Call for nominations:

#### *Original section:*

2.2.4 The call for nominations must be prominently displayed:

- (a) on the front door of the Association offices;
- (b) on at least one notice board relevant to each Academic College;
- (c) on at least one notice board at both the School of Music and the School of Art;
- (d) on at least one notice board in the Union Building or equivalent space;
- (e) on at least one notice board in each of the Tjabal Indigenous Higher Education Centre, the Access and Inclusion Office and the Chifley Disabilities Resource room;
- (f) on the Students' Association website; and
- (g) via any other relevant social media account maintained by the Association, at the discretion of the General Secretary.

#### *Updated section (approved by the RO on 16/07/2020):*

2.2.4 The call for nominations must be prominently displayed:

- (a) on the front door of the Association offices;
- (b) on at least one notice board relevant to each Academic College;
- (c) on at least one notice board at both the School of Music and the School of Art;
- (d) on at least one notice board in the Union Building or equivalent space;
- (e) on at least one notice board in each of the Tjabal Indigenous Higher Education Centre, the Access and Inclusion Office and the Chifley Disabilities Resource room;
- (f) on the Students' Association website; and
- (g) via any other relevant social media account maintained by the Association, at the discretion of the General Secretary.

If campus or the ANUSA office does not re-open before nominations close, there is no requirement to display the call for nominations at the relevant physical spaces.

Ballot box:

*Original section:*

2.3.5 Nominations must be collected in a locked ballot box, to be positioned by the Returning Officer at a venue easily accessible to nominees between the hours of 10am and 4pm throughout the period nominations remain open.

*Updated section (approved by the RO on 16/07/2020):*

2.3.5 Nominations must be sent by email to the address nominated by the Returning Officer. This email box must be accessible by nominated ANUSA staff members. The nominated staff members must confirm the time that the nomination was received by email acknowledgment back to the nominee. Nomination by email will be accepted if it is received during the period nominations remain open.

The call for nominations originally stated that the voting period would be 9am Monday 24 August until 12pm Thursday 27 August. However, due to an unfortunate issue arising from the MSL voting website used for the election the names of candidates were not being listed in the order determined by the Returning Officer.

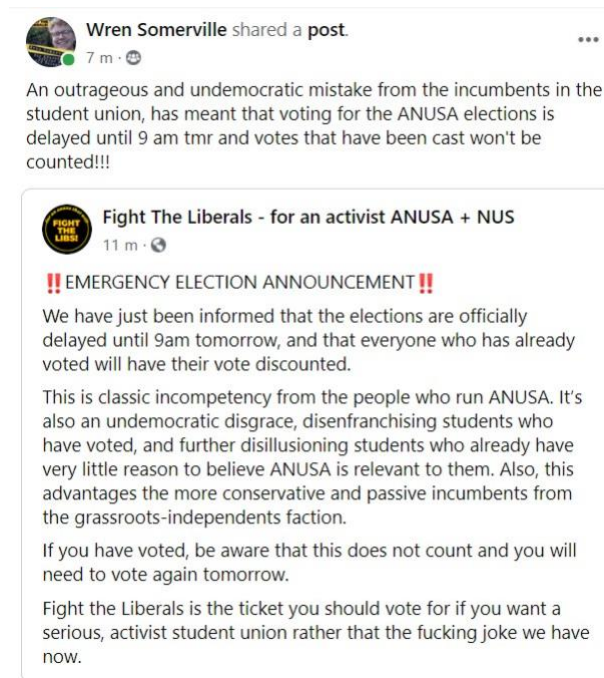
Shortly after 10am on the first day of polling, Monday, the decision was made to close the poll to enable this issue to be rectified. Pursuant to section 3.1 of the Electoral Regulations the Returning Officer declared a force majeure in relation to this and amended the call for nominations to change the polling period to be from Tuesday 25 August until Friday 28 August.

Any votes that were cast in the period before the poll was closed on Monday were discarded and so any student who voted in that period were required to re-cast their vote once voting opened again the following day.

## Significant Issues and Disputes

### FIGHT THE LIBERALS! FACEBOOK POST

Shortly after the polls were closed by ANUSA on the Monday due to the voting issues as discussed earlier, the ticket *Fight The Liberals!*, made a post regarding the incident on their Facebook page which was also cross-posted to the ANU Schmidtposting group by a member of their ticket. The Probity team received a complaint via email concerning this.



The Probity team were initially unsure of what actions, if any, to recommend to the Returning Officer, so Probity requested the Returning Officer's view on this complaint and any directions they could give regarding it.

The Returning Officer found that the post breached section 3.1.8 of the Electoral Regulations since the post specifically disparages any candidates associated with any current members of the ANUSA Executive. Section 3.1.8 states that:

It is an offence to engage in negative discrimination, harassment or intimidation. This includes any repeat unwanted contact to incite somebody to vote, or any other coercive conduct, either online or in person.

The Returning Officer found that in addition to breaching section 3.1.8, the post also breached section 3.1.11 of the Electoral Regulations. That section provides that:

If, in the opinion of the Returning Officer, a candidate or a member of their campaign team behaves in a way that violates the spirit of the Constitution or these Regulations, the Returning Officer may deem that behaviour to constitute an Electoral Offence.

As when the Returning Officer made their decision in relation to this complaint the cross- post to the ANU Schmidtposting had been removed, the Returning

Officer required *Fight The Liberals!* to remove the original post from their Facebook page and officially warned them. No other action was taken.

## SPICE UP! DIVERSIFY YOUR NUS CAMPAIGN VIDEO

The Probity team were alerted to via email of a post on the Facebook page of the ticket *Spice Up! Diversify your NUS* (hence referred to as '*Spice Up*'). The post was of a campaign video featuring the ticket's candidates. In the background of the video it was easily seen

that the video was taken in front of the shops below the Kambri Precinct, which is inside the exclusion zone as defined in Schedule B of the Electoral Regulations. The Probity team was of the belief that the filming of the video, and subsequently posting of it to *Spice Up*'s Facebook page, was an offence under section 3.1.3 of the Electoral Regulations. Section 3.1.3 provides that:

It is an offence to actively canvass votes within the areas specified in Schedule B to these Regulations.

The Returning Officer considered that the exclusion zone has been a long held important component of the creation of a space where campaigning is not carried on. The Returning Officer then found that even though 'actively canvass' is not defined in the Electoral Regulations, this concept includes many activities beyond the specific action of walking up to potential voters and making a pitch to them.

In making their decision regarding the meaning of 'actively canvass', the Returning Officer considered s 304 of the *Commonwealth Electoral Act 1918* (Cth) which prohibits certain behaviour near polling booths and voting places. The relevant part (s 301(1)) states:

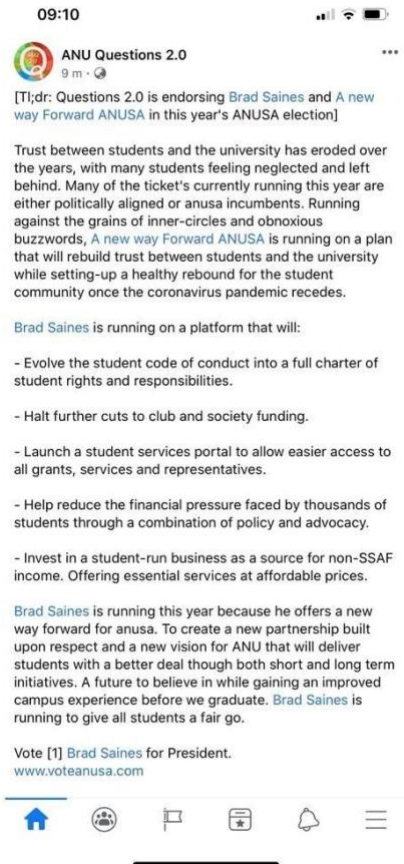
- (1) A person commits an offence if:
  - (a) the person engages in any of the following activities:
    - (i) canvassing for votes in an election;
    - (ii) soliciting the vote of an elector in an election;
    - (iii) inducing an elector not to vote for a particular candidate in an election;
    - (iv) inducing an elector not to vote in an election;
    - (v) exhibiting a notice or sign (other than an official notice or sign) relating to an election; ...

The Returning Officer determined that filming of the campaign video inside the exclusion zone was thus to be considered as 'actively canvass' and accordingly found that a breach of section 3.1.3 had occurred, albeit not intentional.

The Returning Officer required that *Spice Up* take down the offending video from their page. *Spice Up* complied with this request and no further action was taken.

## FACEBOOK PAGE ENDORSEMENT OF FORWARD

Probity received an email regarding a post on the ANU Questions 2.0 Facebook page which appeared to endorse Brad Saines (Presidential candidate) and the rest of their ticket (*Forward*).



Section 3.1.7 of the Electoral Regulations prohibits non-ANU students from campaigning for a candidate in elections. Following precedents from previous elections, Probity considers this to also prohibit endorsements of candidates by non-students too.

Probity considered that this post on the ANU Questions 2.0 page was thus an endorsement of Brad Saines and *Forward*.

As it was not apparent who was an administrator of the page, a member of the Probity team contacted the page via Facebook Messenger to enquire about the post and asked to edit the post to clarify in the post who (if it was a student) was making the endorsement, or to remove the post if they weren't a student.

Probity received a prompt response and the post was updated to clarify that it was made by Brad Saines.

As the post was edited, Probity considered that no further action was to be taken in relation to this.

## USE OF EASELS BY TICKETS

Probity received via an email querying if a ticket was breaching of section 3.1.1 of the Electoral Regulations by using easels which are larger than A3 size, alternatively if section 3.1.11 was breached by the use of them. Section 3.1.1 of the Electoral Regulations state that:

It is an offence to place on any notice board an election notice larger than A3 size.

Meanwhile section 3.1.11 of the Electoral Regulations provides that:

If, in the opinion of the Returning Officer, a candidate or a member of their campaign team behaves in a way that violates the spirit of the Constitution or these Regulations, the Returning Officer may deem that behaviour to constitute an Electoral Offence.

In relation to section 3.1.1, Probity considered that it was not a breach since the easel was a mobile contrivance and hence did not constitute a 'notice board' for the purposes of this section (see also a similar discussion in the Probity 2018 Report).

In regard to a possible contravention of section 3.1.11, Probity considered that the use of the easels did not violate the 'spirit of the regulations'. Although there may be concerns for some regarding accessibility or removal of these posters by ANU Security, these matters do not specifically relate to the letter or spirit of the regulations, as no other rule mentions anything like, for example, where a poster may be placed – outside of the exclusion zones which are very specifically enumerated.

For these reasons, no action was taken in regard to the use of easels by tickets.
