- There is an issue with the management contracts of SA4 as mentioned at the AGM last week. ANUSA had advocated that they should be run by the ANU or that it should go out to a competitive tender process and that people could decide what would be the best value which ANU has not done. ANU are now negotiating directly with UniLodge. Overall demand for pastoral care, SRs and support is high. There have been problems with UniLodge in the past and it is not good to be replicating that current model. The decision itself is pretty unacceptable.
- School of Art and Music Libraries event on Thursday at 2pm in round around the Arts School. Don't think there will be decision on it in the next couple of weeks.
- Concession cards Galvin, Fleur and Talha made a video for Andrew Leigh's Big Ideas Competition. Andrew Leigh said he is pretty interested in the idea. The national concession card is something easy to due and overdue

3.1.4 Treasurer's Report (V. White) [Reference D]

- SSAF each student used to be charged for extra services ANUSA, PARSA, Sport and Rec went to university and then it was split up. The committee was headed by the DVC. There were only 4 student bodies then.
- Trying to put 5 student reps and 4 uni reps so we can outvote the university. The problem with the current legislation is that the money does not need to come to the university. The guidelines are stringent but university can get around it. This will happen when the new senate comes in in July.
- Peer group: joint submission that could be taken to the other body. Some extra money could go into the capital development fund. That would happen through the peer group Treasurers would sit on that. Meet 4 to 5 times a year to figure out what to propose

 - **Victor**: We want to sign a memorandum of understanding that the money will go into university student groups.
 - Leah Ginnivan: if we do it before the legislation, may have a greater bargaining power, other student assocations sorting this out

Item 4: Items for Discussion

- **4.1** Incorporation and meeting requirements (S. Wykes)
- There will be two schedules of membership under the new Constitution. Schedule A and Schedule B. For the Student Representative Council the Executive, Department Officers and General Representatives will be listed under Schedule A and Faculty Representatives will be listed under Schedule B. For College Representative Council the President, Vice-President, General Secretary and Education Officer will be listed under Schedule A and the General Representatives will be listed under Schedule B. Representatives will have breached their meeting requirements if they miss 3 meetings where they are on Schedule A or 4 meetings where they are listed under Schedule A.
- 4.2 Student Accommodation 4 (L. Ginnivan)
- **Leah Ginnivan**: The university is discussing a contract exclusively with UniLodge for SA4 we are not happy about it the management level is not appropriate statistics showed that from the 2000 applications made for accommodation last year only 200 were for UniLodge directly. There is a problem with the existing problems at UniLodge and then there are problems with replicating a current structure when this could be a new opportunity.
 - ANU exempt the discussions from their own procurement policy they said it was technically allowed – will be taking that up at University Council
 - \circ $\;$ Would be good to get a motion from SRC about this good to look at how university is making these decisions
- Issac Wright: Had a meeting with ANU Exchange with David Lemont and Bart Meehan they said 3 tenders were put in for Davey Lodge. Unlike at most colleges, at UniLodge you have to sign a 52-week contract, there is 1 SR per 90 residents, \$3 for washing. When I spoke to Bart and David they said lots of students want this kind of accommodation and that there is a demand. There are a proportion of postgrads who are after that. ANUSA needs to come out strongly against SA4
- **Leah**: Agree with most of what was just said. Some of the university's figures to do with UniLodge are out by a high magnitude.

- **Josh Wiseman**: Was offered UniLodge originally but it was ridiculously expensive comparatively even to student housing.
 - Leah: UniLodge has received National Rental Affordability money which means they are meant to charge 75% of the market rate. No matter who runs it it will still be quite expensive because they need to recoup costs. If ANU managed it they could reinvest the profits.
- Callum Brindley: Was the president at Burton and Garren they should not allow these contract to go out to private companies price is the key to this university has entered into a private partnership they want to make money out of student housing. UniLodge is isolating and it does not have the same kind of collegiate atmosphere because of the way it is built and run. There is no direct student accountability– think ANU should take on responsibility for SA4 and the other three this requires pressure from below
- **Leah**: The issue is about who will manage it. There is a different layout to the other UniLodges with a "third floor cafeteria", common room space etc. It will be a bit different.
- **Nuwan D'Alwis**: Agree to a certain extent –UniLodge is on par with academic results the SubDean is funded through UniLodge ANU pays for the general manager and the bulk funding. We don't want UniLodge to be isolated.
- **Jamie Bryce:** It is not a perfect system though through spending personal time there it is improving very quickly. Academic programs are coming up. It is not as bad as what people say it is.
- **Leah**: Would like a motion that reflects the SRC's position need to reaffirm that we believe pastoral care is paramount and that it is affordable –would like that we can address them in one motion
- Elaine Li, Shan Verne Liew, Skye Webb, Gus Little, Issac Wright and Robin Shannon all expressed interest in working on UniLodge.

MOTION: SRC believes that UniLodge should not be considered for the management of SA4. SRC believes that a non-profit or the University should run student accommodation and SA4. When the contracts expire they should be moved to University management or non-profit. The University should consult with ANUSA, SRs, RAs and PARSA before negotiating the management of student accommodation.

Issac Wright: This is not saying that there is no hard work going on at UniLodge – we just need to know what do we want university accommodation to look like –need to talk about how we want them managed –how is the big company and shareholders affecting students on the ground – would be good not to review the contracts, don't support splitting them – need to know what's being improved – need to start running campaigns

4.3 Gen Rep Portfolios (S. Wykes)

- **Shan Verne Liew**: At the the beginning of the year Christian started Gen Rep Portfolios off –it was not followed through
- **Christian Dent**: There are concerns about an Exec Members pushing a Gen Rep compromised if an exec member is telling a gen rep what to do
- **Skye Webb**: Portfolios need to be more defined,. Was the Gen Rep Coordinator and organized a meeting and only Shan replied.

- **Shaun Wykes**: We need motivation rather than a push
- **Skye Webb**: It is difficult to know what is going on hard to know what people need help with
- **Josh Wiseman**: The best point is the communication we need to communicate better together having a meeting is a really good idea meeting gives a good idea of what everyone is working on gen reps are unsure of what is happening– individually feel disconnected
- **Maea**: We could have a meeting together starting next semester not really done that much in terms of keeping the exec accountable
- **Emily Criticos**: General representatives need to have a meeting gen reps have to meet once a semester to discuss things whether that means just meeting in the pub
- **Leah**: There is a capacity for gen reps being able to work on projects together, get a bunch of things, youth parliament, going to more committee meetings. They could be interesting and good experiences.
- Christian: We could send an exec email to state things that are going on and who can help out
- **Isobel**: Gen reps should have structured meetings it should be the same principle as departments –don't need assistance from the exec at least one a month something put into the constitution
- Maneka: We don't actually have a goal. We need more clarity with portfolios.
- **Robin Shannon**: Could the list of things be sent to department officers as well
- **Ryan Turner**: Alice Mcburney and Scott Walker were an example of how ANUSA can be run more successfully the position of gen rep is what you make it when gen reps want to get involved they can
- **Issac**: Gen reps should be talking to people and bringing motion to SRC to force the executive to do things.
- **Callum Brindley**: Formal meetings are not a substitute for doing things we need to move motions don't need formal meetings for that
- **Maea**: We all have different portfolios the meetings could be good for getting ideas reporting on progress
- **Isobel**: Is once a month enough?
- **Josh**: The risk may be that the meetings become redundant
- **Leah**: It could be once a term, nothing to stop meeting more regularly.
- **Isobel**: Is it so small that they don't have things to meet about?

MOTION: The executive shall send a fortnightly email to General Representative as to ways they can get involved. Gen reps shall meet at least once a term.

5.1 First Year Guarantee

MOTION: In recognition of the fact that UniLodge offers a fundamentally different form of accommodation that comes at to high a cost with too little pastoral care; ANUSA calls for its removal from the First Year Guarantee until it is managed by a not for profit or the university. This motion is to be sent to University Council.

- **Lisa Judge**: UniLodge is not appropriate and too expensive.
- **Callum Brindley**: This is a good motion. It puts pressure on the university. The only option for the university is to move towards managing the lodges themselves.

- Angeline Tan: People want to stay in UniLodge because it is close to campus not everyone
 want a collegiate experience international students can't find accommodation outside of the
 university

PRESIDENT'S REPORT

Leah Ginnivan

Incorporation

Yay, we passed incorporation! This is a big milestone for ANUSA and I think we can all agree that Brody and Shaun deserve many high-fives.

Housing issues

Hopefully 2011 is the last year the ANU will have to resort to temporary accommodation. This year, an oversupply of rooms in Lyneham and UniGardens has been extraordinarily costly for the ANU. Over the year ANUSA reps (big shout out to the amazing Shan Liew!) have been working with the RAs and SRs of these temporary colleges. We are concerned about plans to 'sell off' the remaining beds at UniGardens which would mean students would have to share rooms. While this was part of the contract, we want to make sure people don't have to move during in exam time and are given plenty of opportunity to share with people they know and get along with.

The contracts for SA4 are currently being negotiated and ANUSA is working to make sure they provide for better pastoral and academic support. We have been unsatisfied with aspects of UniLodge's operation in the past and have raised this many times with the ANU.

(I will talk more about this at meeting)

Progress on the co-op has been slow, but we are hopeful about opportunities with community housing providers in Canberra. There is a major review of tertiary student accommodation happening in the ACT. Both ANUSA and the Co-Op will be making suggestions stressing the need for more affordable rental accommodation in the inner north.

Offices

We've been making an effort to get the offices in good shape so they can be used by more people. Woroni moved out last month and we're going to move the Treasurer, Social Officer, General Secretary and Education Officer into that office. Their current office will be used as a second meeting room/ space for collective meetings/ place where General and Faculty Representatives can plot the next batch of wins for students!

School of Music and Art Libraries

There was a lot of confusion around the proposed merger of the Music and Arts School libraries. After getting little response from the heads of school and chief librarian, ANUSA and Art and Music School reps went to meet with the new VC, Professor Ian Young. Professor Young today gave us a formal proposal that students were asked to write a response to. We're working on this at the moment and will respond to the VC by late May. Student concerns about the merger include: restricted access to scores and prints, a lack of study space, Full credit to the music and arts school students involved in this as well as to Fleur and Gal.

ANUSA Neighbourhood Day

A fun side project in the works. ANUSA reps are going to organise a day of volunteering in the local Inner North community. The ANU has indicated it will fund this project and we're now doing up a budget and making contact with local not-for-profits and community groups who could use extra help. The project is aimed at building connections with the Inner North community and also for new students to meet people. A pilot is planned for mid semester 2 and if successful will be held in semester 1 next year sometime after 0 week.

Safety on Campus

A small working party of ANUSA reps and other concerned campus citizens has been working on planning a campaign around issues of sexual harassment and assault on campus. The focus is on prevention through education. After a lot of work on identifying the main issues we'll now be working on a physical marketing campaign, a web presence, and the introduction of campus student safety people (catchy name TBA) who will be able to be a safe and sober presence at events.

Concession Card

For many years, ANUSA and other student organisations have been advocating for a national student concession card – we also think this must include International students. There is some movement on this with the ACT community services minister, Joy Burch, taking it to the next national meeting of her ilk.

Complaint review

Reviewing the Policy for Student Complaint Resolution has been one of the big issues for ANUSA this year.

At this stage our main concerns are

- -policy is vague and unhelpful on matters that might be sensitive or timely
- -students concerned about the DoS role
- -a focus on informal problem solving needs to be kept while ensuring serious matters are dealt with appropriately
- -the policy ostensibly deals with issues of harassment and assault but makes no reference to these issues.

I have asked widely for feedback on this policy and invite any and all suggestions/comments.

In addition to the policy review we are proposing a webpage that has clear directions on the policy as well as examples and links to the relevant people's emails. We'll also get it so it's the first thing that comes up when you search for relevant terms on the ANU website.

Strategic Plan

The ANU is currently making its strategic plan until 2020. The VC will soon be coming to explain it to student reps and we'll be giving our input on a range of student issues. After the consultations, the VC will write a discussion draft to be circulated for comment. VC is coming to a JRC meeting soon!

Exchange Program

The poor quality of the official ANU Exchange program has been a problem for some years now. The ANU has not had a dedicated senior-level person with the International portfolio. We strongly believe that a PVC International would assist in the program. Co-ordinating the exchange program through the colleges (and not, as is currently the case, through the Registrar) would also assist hugely in making exchanges worthwhile and relevant.

Graduations

We suggested that graduations have a student speaker, something that has been suggested by many in the past. Wrote a proposal, got VC approval, voila, student speakers at this years' graduations.

Government Policy-other

The Education officer and Education committee have been involved in action and submissions to the Base Funding Review and the current review on student income support.

Other

I have been involved in helping set up a student-led forum for the 50th anniversary of Australia-Korea diplomatic relationship. I'm also assisting a student in setting up an informal group for students with Asperger's syndrome.

VICE-PRESIDENT'S REPORT

Incorporation

As you all know, we passed the content proposed Constitution at last Tuesday's AGM, complete with Legal Advice from DLA Piper here in Canberra. We have put forward a submission to University Council, for their meeting at the end of this month. With the approval of the Council, we can lodge the paperwork with the Office of Regulatory Services in time for next Semester. We know this is only the first step along the way, and acknowledge that not everyone was happy with every part of the Constitution, but it is an extremely good start and an improvement on the current document, so thank you all for your input and support over these last few months.

ANUSA Survey

The Association's survey will be released very soon, and we will have it open for as long as we can, depending on the requirements of the Quality and Standards Sub-Committee, to allow maximum student input. We will be assessing the standard criteria, including student demographics, teaching and learning methods, accommodation, employment and youth allowance as well as adding a few new sections on exchanges and international opportunities, the 'student experience' in general.

Exchanges + International

I am about to kick of an investigation into the exchange programs and general international opportunities here at the ANU. There was some research done last year into the ANU's lack of exchange partners comparative to other Go8 universities, but we'd like to take this further and look into the exchange program as a whole, including also the complexity of the application process, the value of the exchange personally and academically, as well as the credit transferring process once students have returned.

Another aspect of this is to strength ANU's profile from a student level, independent of the International Office. The idea has been floated to create a student-produced information video, as well as strengthening the student linkages within the IARU network. If you know of anyone that has any ideas or even general comments, both positive and negative, about exchanges, please let me know.

Logo Competition

The logo competition was concluded two weeks ago, with the winner being selected from a surprising number of entries. We will be working with the winner over the coming weeks to combine a few of his designs into one, with the introduction of the new logo expected to coincide with the Association's incorporation.

Meetings

EMPC (Environmental Management and Planning Committee)

- The Solar panels have been having a few problems but should be functioning properly very soon. ANU Green and F&S would like to have an Official Opening before the end of term, but I'm in touch with them so we'll be in on the organising as well.
- The committee has expressed its general approval for a proposal to incorporate sustainable education into degrees here at the ANU. The idea is essentially that all degrees would have some compulsory content or even a whole course, which studies the application of sustainable practices to

TREASURER'S REPORT

Victor White

Budget

Please see budget attached for this section. There is nothing exemplary to report in the last period. Spending is ahead on the Legal Officer and this line item will go over budget. This is due to the increased salary meaning that the Legal Officer fees are now subject to GST. As stated previously there was a very healthy profit recorded in O-Week and the association is in a strong situation financially.

Student Amenities Fee

I am currently in discussions with the Treasurer of PARSA and the CEO of ANU Sport and Recreation about preparing a joint memorandum about how we would like the Student Amenities Fee divided up. We want to present a united front to the University when they are making decisions based on how to split the money. This will be done through the Peer group that was previously in place. I will speak more to this in my report.

Collectives

After my discussions with the auditor we should be withholding payments made to bodies that do not have an ABN where they are not an individual. Whilst the Collectives are part of ANUSA, they are autonomous and the Treasurer does not (and should not) have the power to tell them how to spend your money. When Collectives invoice ANUSA with the ABN it allows us to keep proper and transparent records as well as ensuring that Collectives have the financial autonomy to spend their money.

- Having an ABN (as well as your own constitution) ensures autonomy by giving them control over their
 own affairs. Depending on what your constitution stipulates you may have to disclose your spending
 to your collectives and getting an ABN will not affect this. They will **not** have to report expenditure to
 the ATO, as all organisations with a yearly spend of less than 6,000 dollars are automatically taxexempt. This means they will not have to do BAS statements.
- **Getting an ABN will not remove Collectives from ANUSA**. It would not distance ANUSA from the collectives either. It is simply an recognition that they enjoy financial autonomy from ANUSA. To remove Collectives from ANUSA would require significant amendments to the ANUSA Constitution.
- If Collective's receive any income from any other organisation, person or business other than ANUSA they must **legally** have an ABN. It is not enough to use our ABN, as ANUSA does not effectively have control of these funds.
- We already require that all clubs and societies registered with us have an ABN. Even though they have
 a separate ABN they fall under our insurance policy. Obviously Collectives have a very different role
 than clubs and societies in the ANUSA framework, however, it is an example of groups that do fall
 under ANUSA's framework.

EDUCATION OFFICER'S REPORT

Review of Student Income Support

I made a submission on behalf of ANUSA to the recent Federal Government review of student income support. Essentially this was a review of the recent youth allowance reforms that the government introduced in 2010. In the submission I stressed the point that whilst the recent reforms have been positive, the system is still inadequate. In particular I emphasized ANUSA's position that the age of independence should be reduced to 18, that both the parental income test for dependant youth allowance is far too low, that student's should not have their youth allowance payments reduced for working too much, and that the current classification scheme for regional and rural students is completely absurd. The ANUSA submission will be put up on our website shortly.

Consultation Session on Youth Allowance

On Friday 29th April I attended a consultation session at the Department of Education, Employment and Workplace Relations (DEEWR). This formed part of the Federal Government's review of student income support. It was run by Professor Kwong Lee Dow, former Vice-Chancellor of Melbourne University. I stressed the same points that were made in the submission, and Professor Kwong appeared relatively receptive. It was widely accepted in the room that the current system simply isn't good enough.

International Student Visa Review

I made a submission to a Federal Government Review on International Student Visas. I worked with Angeline Tan and Elaine Li, who may wish to elaborate on international student issues in this meeting. The points we made in the submission were regarding the high costs of both living in Australia and applying for the Visas, our desire for International Students to have a positive experience in Australia not just at University, and the benefits International Students provide to the Australian economy especially in areas where there is a recognized skills shortage.

Federal Budget

The Federal Budget was overall fairly encouraging in terms of higher education. The main changes were:

- Students who pay their HECS fees upfront will have their 20% discount halved. It seems unfair that just because some students have more money when they start University they receive a discount on their fees. The \$480 million savings the government will make should be reinvested in higher education, although it is unclear at this stage where the money will go.
- \$110 million will be invested into regional universities. It is unclear if ANU will receive any of this funding.
- The government committed to funding 500,000 new university places in preparation for the university sector become demand-driven in 2012.

TEQSA Legislation

The Tertiary Education Quality and Standards Authority (TEQSA) proposed legislation will be presented to parliament soon. TEQSA is to be introduced next year as a national regulatory body for higher education, replacing the current state-based regulators which operate unevenly. A senate committee report has ensured that universities have the ability self-accredit courses of study, which was unclear in the previous legislation. Both the National Union of Student's and Universities Australia have endorsed the legislation. The ANU stands to benefits from this new regulatory body in that it will be recognized leading and unique teaching and research university.

YMCA ACT YOUTH PARLIAMENT

The ACT Youth Parliament is held annually at Old Parliament House. It gives people aged 15-25 the opportunity to participate in engaging political debate. If you are interested in participating, log on to the website to sign up. http://ypact.org.

Fair Fares For All Students

Firstly, well done to Fleur Hawes, Talha Baseer and Galvin Chia for their fantastic video. Check it out on the ANUSA facebook page. As you know, Australia has no national concession card. A motion has been moved by Labor backbencher John Hargreaves MLA in the ACT to bring this issue to the forefront of the federal agenda and look into the creation of a national concession card scheme. NUS is running a campaign on this and it would be fantastic if ANUSA did so as well. If you're interested in this please let me know.

Education Committee

Education committee met on Tuesday 17^{th} of May. I'll report on the discussions that took place verbally. Previously we'd met to discuss ANUSA's response to the youth allowance submissions. The idea of compiling a 'how to live cheaply handbook' was also suggested, and may be something ANUSA reps may want to look into.

NUS Education Conference

The annual education conference will be held in Perth at the University of Western Australia and Curtin University on the 6-8th of July. Let me know if you would like to attend and we can have an ANUSA delegation going. All expenses will be at least partly subsidized by ANUSA and NUS.

SEXUALITY OFFICER'S REPORT

Since the start of term two Sexuality Department has continued its busy pace set during term one. Of major note is the Sexuality Collective's vote to change its name to the Queer* Collective/Department. In preparation for the incorporation of ANUSA, the Collective has also passed a constitution, which the department has been without for several years. As a result of this, relevant to this meeting, the collective will vote to direct the vote of the Officer at SRC Meetings unless not practical and not relevant

Also, at long last, by the time of this SRC, all financial concerns should have been resolved.

Queery discussion forums are still happening fortnightly, with this term's first discussion being Gay Marriage: Do We Want It?

The Collective's fortnightly meetings always achieve quorum, but we have to review the implementation of our safer spaces policy follow concerns that some people do not feel comfortable in meetings. UniGardens
