#### **Item 3: Executive Reports**

#### 3.1 President's report (B. Gill)

Report tabled. Taken as read. Gill highlighted that:

- Feedback surveys for SRC and CRC will no longer confidential,
  - Representatives will still be able to raise sensitive issues individually with Executive members
- Focus group on mature aged students and young parents is being set up (because ANUSA does not at present cater for this group particularly well)
  - Please get in touch at sa.president@anu.edu.au if you have any questions
- SSAF Agreement
  - Progress is being made with the major sticking point continuing to be the roll over of funds unspent at the end of the year
  - Student organisations will be asked to give a midyear budget update to help manage funds and ensure that they are spent on time
- The audit is on track, finalized statements ready for AGM
- ANUSA membership gap
  - Non-award students are currently not covered under constitution and therefore struggle to access ANUSA services (such as Welfare officers)
  - o Investigate changing the constitution
- ANUSA/PARSA will begin co-funding fitness/cooking classes next week
  - Details on the website
  - o Yoga and BodyPump will be at ANU Sport
  - o Cooking classes will run out of the BKSS
- HR Consultancy: we need an HR Framework, will be appointing a consultant

## **Item 5: Discussion Items/Motions on Notice**

## 5.1. NUS Presentation and Accreditation (T. Nock)

- Context: Presentation was borne out of a motion in SRC 1 to invite NUS National Office Bearers to address SRC on their activities to help facilitate a discussion around re-affiliation.
- There followed three presentations from
  - Rose Steele (NUS National President)
    - Achievements of NUS include lowering the age of independence, original defeat of deregulation, extension of rent assistance, led campaign against VSU, HECS reduced, reintroduction of student amenities fees
    - NUS represents students to State Governments and to Federal Governments as the peak student representation body
  - o Tom Nock (NUS National General Secretary and ANUSA member)
    - NUS does not have individual student members, it has student organisations that are its members
    - Used to operate under Universal Student Unionism
      - At this time, student unions around the country were well funded and a powerful voice for students
    - VSU was introduced and many student organisations folded because their funding either decreased or their referent universities withheld SSAF funding
  - Hannah Smith (NUS National Education Officer)
    - Updated SRC on the progress of the national campaign against
       University Fee Deregulation
    - Primarily done through large scale actions (such as NDAs and lobbying elected officials and MPs)
  - These three office bearers held a Question and Answer session from SRC representatives
- There then followed short presentations from Megan Lane and Jock Webb as delegates from the 2014 NUS National Conference
  - Jock Webb (ANUSA Education Officer and 2014 NUS Delegate proxy)
    - Aligned with the National Independents faction at NUS
    - National office bearers need to seriously consider how they hold themselves on the conference floors, how they are run, security etc.
    - I personally see a huge amount of value in NUS.
    - It's value should be measured in political lobbying power, not just the amount of posters or materials we receive.
    - It would be ineffective to remove our contribution, if one of the major issues that students have is the defunding of departments due to a lack of funds.
    - In terms of broad student movement, they have the power to be a voice for the students in a broad sense and with more resources, this can be done more effectively.

<u>Procedural Motion 4: Reports interjected to move a procedural motion accepted by the Committee.</u>

Motion: That the Chair pass to Vice President, James Waugh, to allow Megan Lane, to make her report, after which Chair will be returned to Miss Lane. Status: Accepted.

- Megan Lane (ANUSA General Secretary, 2014 NUS Delegate, 2015 NUS ACT Women's Officer)
  - Aligned with Student Unity faction at NUS Conference
  - She did not experience harassment and at no time during NUS felt uncomfortable or unsafe.
  - Some heckling is to be expected at a large student conference with a dynamic floor and contentious debate.
  - No organisation is perfect and NUS is no exception.
  - Whether or not you agree with the funding/defunding of office bearers, you must agree that without adequate financing, NUS cannot afford to fund positions it has no money for
  - On this issue, the more money NUS has, the better they can represent us and other minorities.
  - Lane refuted suggestions that she had not conducted herself appropriately on conference floor or that her membership of SU was linked to misconduct
  - On her role as the ACT Women's officer, Lane noted that while State Women's Officers were highly useful in states with many campuses and student organisations, in the ACT where there are only two affiliated campuses (ANU and UC), the role was less necessary but she was prepared to help the ANUSA Women's Officer engage more with her national counterpart.
- Both Webb and Lane answered questions about their roles as delegates and office bearers.

<u>Procedural Motion 5: Reports interjected to move a procedural motion accepted by the Committee.</u>

Motion: To suspend the Student Representative Council for five minutes to allow Representatives to take a break after 2.5 hours of debate and presentations.
