- **Ryan**: What is a crisis worker?
  - Fleur Hawes (POC): Tentative budget which depends on SSAF negotiations mental health services at ANU are inadequate particularly around assessment would be good for them to have an international background
- **Ryan**: Please clarify what environmental machines are.
  - **Fleur** (POC): Talking to Interhall Green, Union Envirobank to have in Union scans and takes in material, crushes it and gives some sort of credit
- Ryan: Faculty camps in original budget it was \$20,000 and now it is \$15,000
  - Fleur (POC): Alice and Fleur currently meeting with the Heads of every faculty getting ideal amount from the faculties
- **Ryan**: Looking at long term assets worried about 2013 and having SSAF repealed doesn't take account of that is there any long term vision in terms of expenditure?
  - o **Fleur** (POC): Quite a lot of funding will go to capital outlay
  - **Victor**: Also a peer group development fund would not go to capital works capital outlay is for putting money away
  - o **Fleur** (POC): Also looking at investing in enterprises that do have that long tem benefit-
- Ryan: Considering property development for student housing?
  - o Victor: ANUSA has \$750,000 in reserves which we could access for those kind of projects
- Sam Thorpe: How far have the conversations progressed re SSAF?
  - Leah (POC): Earlier in the year we had an undertaking from the VC that it would all go to democratically elected student bodies emailed VC to see if this was the universities position Deane said she may take money off the top which ANUSA is opposed to the issue is what constitutes a student organization (Griffin Hall not open to all students, should be funded by university and Griffin Hall membership fees) had VCs word on three occasions that it would go to democratically elected student bodies
- Gab Coburn: What has happened to the welfare fund?
  - Victor: Still done there, but still at \$50,000
- **Gab**: Why has telephone gone up 300%?
  - Victor: Mobile phones could be covered this incurs significant costs for reps something which should be looked at

# **5.3:** Amendment to section 14(6) of the Constitution **(S. Wykes)**

That section 14(6) of the ANUSA Inc. Constitution be amended to read:

- (6) The President must, subject to the Constitution, the Regulations and Policy of the Association:
  - (a) represent Undergraduate students on University Council;
  - (b) represent Undergraduate students on other bodies, including other committees of the University, or after consultation with the SRC, appoint members of the Association to such bodies;
  - (c) be the spokesperson of the Association on matters of concern to members of the Association;
  - (d) make every effort to inform members of the Association of issues relevant to their welfare, and of decisions made or actions undertaken by the Association on their behalf;
  - (e) be available to Undergraduate students to provide advice and advocacy;
  - (f) make a report of the activities of the Association to the Annual General Meeting of the Association;
  - (g) take such other action as she or he considers necessary in the interests of members of the Association;
  - (h) represent the views of the Association to the media;
  - (i) be primarily responsible for the Association's employees, in conjunction with the Executive;
  - (j) consult the relevant Department Officer when making appointments to various University committees; and
  - (k) consult with the CRC before appointing a student to any College board or committee.

• Tried to amalgate that President sat on all bodies and committees relevant to students but we need to have a specific reference to Council.

Really need to pass this so we are triple sure the President can sit on Council.

### **5.4:** Amendment to section 14(11) of the Constitution (C. Dent)

That section 14(11)(a) of the ANUSA Inc Constitution (Education Officer) be amended to read:

(a) oversee the implementation of the higher education policy of the Association

to

(a) oversee the implementation of the higher education and related policy of the Association

AND that the following subsections be inserted:

(e) on behalf of the Association, liaise with the national <u>and local</u> bodies on relevant campaigns relating to higher education; and

(f) prepare submissions on behalf of the Association to Government inquiries and reviews on Higher Education matters.

Moved: Christian Dent

- Won't change the role but defining it a little bit more
- Subsection (a) what has been dealt with is not necessarily in the role of the officer (national concessions cards) policy outside of higher education
- (e) NUS etc
- (f) Preparing submissions (base funding, student income support) to make sure these submissions are done and if they fall within higher education and related it is important that these submissions are put

## **5.5:** Amendment to section 26(7) of the Constitution (P. Rumble)

That section 26(7) of the ANUSA Inc. Constitution be amended to read:

"Each year the Association must give each Department an amount of no less than \$5000 for use in respect of the activities of the Department. <u>Each collective will be audited yearly as part of ANUSA's independent audit.</u>"

### Moved: Penny Rumble

- This is not about the SSAF even without the SSAF ANUSA is getting half a million each year
- Collectives are more than a service they empower people
- Next years budget is generous to the departments
- \$1000 doesn't allow the collectives to do shit (*Penny was named*)
- Queer collective has boomed because Ben Koval spent \$7000 need to make sure each year is a strong year
- The Officer is required to run two queer orientated campaigns each year
- The accountability is quite good– every dollar has to be approved by collective, and then reported to SRC
- Not fair for collectives to go to GAC
- Encourage everyone to vote

# Seconded: Brett Jones

- Deputy Queer Officer this year Jelly Babies coordinator GAC hasn't had the money to give to us
- Key factor behind strength is the funding \$1000 hasn't helped the collective common assumption that collectives aren't relevant is so far from the truth
- Discrimination and isolation still exists. We need to ensure collectives have a strong presence and remove isolation from within these communities.

  - o Victor White: \$1800 each

## **Speakers**

**Victor White:** Will be voting against because we don't know what will be happening with SSAF – already  $$50,\!000$  in budget for collectives – not enough money currently to support them to \$5000 – until it reads that there should be an audit and we see what happens with SSAF this motion should not pass

**Renee Jones:** Would love to have this money and it would be great for Collective activeness – Queer Collective has done a lot but Women's Collective has also done a lot – hosting NOWSA at ANU next year – referred to as "most active Women's collective in Australia" – Enviro Collective has also does a lot

**Gab Coburn:** Member of Queer Department of 4 years and member of Women's Department for 2 years – it is important for collectives to be autonomous groups so they can have a voice across campus

**George Ober**: Don't want to bash the Collectives or appear Anti Collective –Ben Koval was the greatest Sexuality Officer ANU has ever seen – potential for collectives to do so much work – we must take ourselves seriously and must ensure money is being used properly

**Friendly Amendment**: Each collective will be audited yearly as part of ANUSA's independent audit.

**Isobel Morphy-Walsh:** Money needs to get department approval and be signed off my three people and have to report back to SRC and this is the same for all collectives! – Victor said it wasn't an imperative motion, but it is because we don't know what may happen to collectives – growing collectives has relied on the officers using their own money

**Sam Thorpe:** Important that the Students Association is accountable for money – association will be awash with money for six years – no reason to spend money before we have that money – motion doesn't come at a time when it is needed – may be something to look at next year – but until that happens we can't say this expenditure is necessary – constitutional baseline of \$1000 – can't say that if it goes down to \$1000 they won't exist

**Kate McMurtrie:** Am the Women's Officer this year and have had a blast with the Collective – in admiration of Officers who don't have an honorarium – Collectives are a place for intellectual arguments, fun and to be there for each other – ANU can do better than La Trobe

**Dan:** From the Environment Collective – EC started the 4 dollar lunches which people who have run Students Association have said they will do for years – ridiculous idea that they are not working

**Ben Koval:** Collectives do provide social services but they deal with much deeper issues – Penny put together a proposal document and that was hours of work for Penny that she didn't get paid for – with \$1000 you can run 2 or 3 events, can't get things printed – can't operate under \$1000 – get real about longevity of these places – essential to ANUSA – if people feel safer then the collectives are achieving their objectives – people should support the collectives on this campus

**Penny Rumble** (Right of Reply): This isn't about the SSAF and personally don't expect SSAF to be around that long – five grand each isn't that much – when collectives get 1000 a year, they die

### **5.6:** Amendment to section 13 of the Constitution (S. Wykes)

That Section 13 of the Constitution be amended to read:

(1)

- (a) Any elected Representative who is constitutionally required to sit on any or all of the SRC or CRC, or to attend OGMs or AGMs, and who fails to attend:
  - (i) 3 meetings which are either General Meetings or council meetings for which they

are included on Schedule A of the council membership; or

- (ii) 4 meetings for which they are listed on Schedule B of the council membership; is to be removed from office.
- (b) For the purposes of section 13(1)(a), failure to attend a meeting includes attending a meeting for less than one hour if that meeting is longer than one hour in duration.
- (c) The General Secretary must take reasonable steps to notify any elected Representative of provisions section 13(1)(a) and (b) if they miss a meeting.
- (d) Where the General Secretary is satisfied that a Representative missed a meeting at which their attendance was constitutionally required due to exceptional circumstances, the General Secretary may declare that the missed meeting is not to be counted for the purpose of section 13(1)(a).
- (e) Elected Representatives must notify the Executive of their intention to take leave from their elected position for auxiliary purposes in writing. A request for leave must be made at least three Teaching days prior to a meeting. This leave, if granted by the Executive, will negate the operation of sections 13(1) (a), (b), (c) & (d)
- (f) Where leave is not granted, the elected Representative may refer the matter to the Disputes Committee. In reviewing the failure to grant leave, the Disputes Committee may affirm or overturn the decision of the Executive.

(2)

- (a) Any ordinary member of the Association may make an application to the Disputes Committee seeking review of a declaration made by the General Secretary under section 13(1)(b). In conducting a review commenced under this section, the Disputes Committee may affirm or overturn the declaration of the General Secretary.
- (b) A person removed by the operation of section 10.4.5(a) may appeal to the Disputes Committee, for reasons including, but not limited to, instances of personal emergency, consistent poor communication of meeting times, or insufficient notice of meetings.
- (c) If a Representative is successful in their appeal to the Disputes Committee under section 10.4.6(b), the Disputes Committee must reinstate them in their position. In reinstating the Representative, the Disputes Committee may hold that any meeting missed by the Representative is not to be counted for the purposes of section 13(1)(a)
- (3) The Association must maintain Regulations providing for the filling of casual vacancies in any of the positions specified in Schedule 1.

### Moved: Shaun Wykes

- Under the current system when reps are failing to attend they are automatically kicked off and then have to go to the Disputes Committee but it is sometimes obvious that the reason they missed was an emergency and it is clear they will be reinstated
- Disputes Committee is a huge process.
- General Secretary will have more of a discretion to allow people to miss meetings but ordinary members can still make a disputes of the Gen Sec's ruling to the Disputes Committee.

### Seconded: Sam Thorpe

• Speaking rights waived.

### Questions

- **Gabe Coburn:** How does this fit into other things like meeting time changes at the last minute?
  - o **Shaun:** The Gen Sec must still give reps sufficient notice
- Robin Shannon: Would this provide for compulsory classes?
  - o **Shaun:** It is discretionary but it is generally considered exceptional circumstances.

- **Sam:** Compulsory classes haven't counted in the past as exceptional circumstances.
- **Brody:** Does that mean that the definition of exceptional circumstances will be a base of precedent from disputes committee and the gen sec's interpretation?
  - o Shaun: Yes

### **5.7:** Amendment to section 22(1) of the Constitution (S. Wykes)

That "teaching" be removed from Section 22(1) of the ANUSA Inc. Constitution to be in line with ACT Legislation:

(1) This Constitution may be amended by Special Resolution at any general meeting (including an AGM) in accordance with the rules for General Meetings in section 8 except that at least twenty-one (21) Teaching days notice of the Special Resolution shall be given to members and a decision to amend the Constitution shall require the support of seventy-five per centum (75%), to the nearest whole number, of ordinary members present and voting.

Moved: Shaun Wykes

• This is just to be in line with legislation. Have had to give excessive notice for these changes.

### 6.5 Electoral Regulations (R. Turner)

## <u>Preamble</u>

- 1. Student Unions have a vital role to play at each university across the country, providing essential services and amenities to students in order to foster student retention, diversity and community on campus, complement students' formal education, and engender a positive university experience.
- 2. The election of student representatives must occur in a fair and democratic fashion, else the elections—and as a corollary, the student union—may lack legitimacy and not adequately reflect the voting intentions of the student community.

### **Platform**

1. The Australian National University Students' Association Incorporated recognises that the Election Regulations prescribed in the *Constitution and Regulations* of the Association are inadequate, particularly in respect of the powers conferred on the Returning Officer and the Probity Officer in respect of the commission of an electoral offence.

#### Action

- 1. The General Secretary of the Association is to create a working group comprised of ordinary members of the Association to review the electoral regulations of the Association. The terms of reference of the review will include, without excluding other relevant matters, the following:
  - a. The definition of an electoral offence;
  - b. The powers and role of the Returning Officer and the Probity Officer;
  - c. Limitations on campaign related expenditure;
  - d. Disclosure requirements; and
  - e. Campaign regulations.
- 2. The General Secretary is to advertise the working group on the website of the Association and invite submissions from members of the Association.
- 3. The working group will develop a proposal (or proposals) for the alteration of the Election Regulations to be presented at the first meeting of the Student Representative Council in 2012 and, subsequently, at a General Meeting of the Association.

## Moved: Ryan Turner

• Conduct of elections this year had major problems - the Probity Officer has very little power currently – this motion will create a working party to look at electoral regulations at other universities

# Seconded: Tara Mulholland.

### **Student Representative Council 5** (Wednesday 28th September)

### Drama Major to Minor

Remy Grahan and Mark Tee Ka Foo from NUTS and SASS respectively came along to talk about the Drama major and how it is being demoted to a minor. The discussion covered consultation of students in changes to their degrees and how much to get this information out to students so they can be part of the decision making process. A motion was passed stating that ANUSA condemns the lack on consultation in the downgrading of the Drama major and the policy of forcing students to financially justify their academic interests and that ANUSA endeavors to seek the views of drama students on campaigning to reinstate drama as a major. It also stated that ANUSA should further explore ways to engage students.

#### Major issues raised in Executive reports

- The font on the new ANUSA logo needs to be checked for copyright.
- Dallas Proctor replaces Josh Wiseman as Gen Rep: welcome, Dallas.
- Spoke about the Grants and Affiliations Handbook including giving money to "illegal activities" and whether this should be in there, as the law isn't always right (an example of the debate between legal positivism vs legal realism, as any law student will tell you). These reports were useful for the incoming team to hear too. I think there's definitely room for improvement in how we operate and we'll have more of a chat with the 2012 team about everything we've learnt in the last 11 months.
