Motion 5.2: Election Regulation Changes for Postgraduate positions

Preamble:

The current election regulations do not provide for the elections of Postgraduate students, or the HDR, Postgraduate Coursework and Undergraduate Officers. These changes will allow for the proper elections of these positions.

Motion:

The following amendments are to the Election Regulations:

Amend regulations 2.1.7 and 2.1.8 of the Election Regulations to read:

- 2.1.7 A member is only entitled to stand for election to a College Representative position of a College if they are enrolled in an undergraduate or postgraduate program in that College.
- 2.1.8 Subject to 2.1.8A to 2.1.8C, a student is entitled to vote for a College Representative position if they are enrolled in an undergraduate or a postgraduate program in that College.

Add the following provisions:

- 2.1.8A Only an Undergraduate Student is entitled to vote in the election of an Undergraduate Student College Coursework Representative or in the election of the Undergraduate Coursework Officer.
- 2.1.8B Only a Postgraduate Coursework Student is entitled to vote in the election of a Postgraduate Student Coursework College Representative or in the election of the Postgraduate Coursework Officer.
- 2.1.8C Only a student enrolled in a higher degree research program is entitled to vote in the election of a Postgraduate Student College Higher Degree by Research (HDR) Representative or in the election of the HDR Officer.
- 2.1.8D An existing ANU student who has been admitted to, applied for a program, or provides a statutory declaration of their intent to apply by no later than November 30 immediately following the election for the program is entitled to stand for election for positions for which a student enrolled in that program are eligible to stand.
- 2.1.8E A student elected based on eligibility set out in 2.1.8D must make good faith efforts to secure enrolment in the program for which they were elected and cease to hold office if they have not been admitted to the program in respect of which they were elected by 31 December following the election.

Add regulation 4.6A to Election Regulations:

4.6A HDR, Postgraduate Coursework and Undergraduate Officers

- 4.6A.1 If a vacancy occurs in a position of HDR, Postgraduate Coursework or Undergraduate Officers, the President, after consulting with the EDC in person or in writing, must nominate an ordinary member of the Association enrolled in a program qualifying the member to stand for that position, to fill the vacancy as soon as practicable.
- 4.6A.2 The President may, upon consultation in person or in writing with , the EDC, co-opt an ordinary member of the Association enrolled in a program qualifying the member to stand for the position, to be an interim Officer until the next Education Council meeting of the Association or until the vacancy is filled in accordance to 4.6A.1
- 4.6A.3 If the vacancy is not filled before the next Education Council meeting of the Association, then:
 - (a) whoever convenes the next Education Council meeting of the Association in accordance with this Constitution must include on the agenda a call for nominations to fill the vacancy; and
 - (b) at that Education Council meeting any ordinary member of the Association enrolled in a program qualifying the member to stand for that position may nominate to fill the vacancy in accordance with the Regulations.

4.6A.4 For the avoidance of doubt, Regulations 2.1.8D and 2.1.8E do not apply to the filling of a casual vacancy.

Delete Election Regulations 4.5 and replace with:

4.5 College Representative

- 4.5.1 If a vacancy occurs in a position of College Representative, the President, after consulting with the EDC in person or in writing, must nominate an ordinary member of the Association enrolled in the relevant College and a university program qualifying the member to be elected to that vacancy to fill the vacancy as soon as practicably possible.
- 4.5.2 The President may, upon consultation in person or in writing with the relevant College Representative or, if unavailable, the EDC, co-opt an ordinary member of the Association enrolled in the relevant College and a university program qualifying to member to be elected to that vacancy to be an interim College Representative until the next College Representative Council meeting of the Association or until the vacancy is filled in accordance to 4.5.1.
- 4.5.3 If the vacancy in position of College Representative is not filled before the next Education Council meeting of the Association, then:
 - (a) whoever convenes the next Education Council meeting of the Association in accordance with this Constitution must include on the agenda a call for nominations to fill the vacancy; and
 - (b) at that Education Council meeting any ordinary member of the Association enrolled

in the relevant College and a university program qualifying the member to be elected to that vacancy may nominate to fill the vacancy in accordance with the Regulations.

Amend regulation 2.1.6(c) of the Election Regulations to read:

(c) the positions of University Council Member

Amend regulation 2.2.7 of the Election Regulations to read:

The General Secretary must release an Expression of Interest (EOI) Form which gives all ordinary members the opportunity to indicate their interest in running for office on ANUS A on a ticket.

Amend regulation 2.2.9 of the Election Regulations to read:

Reasonable efforts must be made by the General Secretary to make the form available for completion by

all ordinary members at least 21 days prior to the notice of the Call for Nominations.

Amend regulation 2.5.2 to read:

2.5.2 The Returning Officer must ensure that procedures are in place to:

(a) limit each ordinary member of the Association to voting no more than once;

(b) only voting for a position for which they are entitled to vote; and

(c) ensure that the way in which any voter casts their vote is not revealed, either when that member votes or at any later stage, including by ensuring that information capable of identifying

a voter is decoupled from their ballot and stored in a way that preserves anonymity.

Amend regulation 7A.3.10 of the Election Regulations to read:

7A.3.10 A Department must ensure that undergraduate and postgraduate students have equivalent

rights to vote and stand for office within the Department.

Amend regulation 8.2.3 of the Election Regulations by deleting the word "undergraduate".

The following amendment is to the Finance Regulations:

Amend Regulation 3.3.2 by deleting the word "undergraduate".

Friendly amendment on notice:

Amend 2.1.7 of the Election Regulations to read:

2.1.7 A member is only entitled to stand for election to

(a) a College Representative position of a College if they are enrolled in an undergraduate or

postgraduate program in that College and a student in the relevant academic career for the position for

which they nominate.

(b) Undergraduate Coursework Officer if they are an undergraduate student;

(c) Postgraduate Coursework Officer if they are a postgraduate coursework student;

(d) Higher Degree by Research Officer if they are a Higher Degree by Research Student; and

(e) Parents and Carers' Officer if they self-identify as Parents or Carers

Should an Officer or Representative elected at OGM2 be found to be ineligible for the position within a fortnight of this meeting, the eligible candidate with the next highest number of preferences will be taken

as elected to the position.
